

Dear Business Owner

The UK government are determined to lock down and destroy all small/medium businesses in this country. There are reasons for this that are nothing to do with a virus. You may want to research this further for yourself. If you close now, you will probably never open again as the government will extend the lockdown further and you will most likely lose your business. There will be no more small/medium businesses left if we do not stand up to the government NOW.

The government does not have the right to keep decimating the lives of healthy people on the basis of a virus which for most people, will range from either no symptoms at all or a flu-like illness.

If you are a small business you DO NOT have to just roll over and close. Asking you to close is simply an OFFER. We will explain more about how to do this in this letter.

We currently have hundreds of thousands of so-called 'cases'. 'Cases' don't mean 'infections' and it's common knowledge that approximately 90% of the PCR positive 'cases' are false positives. Therefore, a huge amount of 'cases' are irrelevant as deaths and hospitalisations are in line with the 5 year average and we are not experiencing any excess hospitalisations or deaths for this time of year.

So-called asymptomatic cases have never been the driver for spread of infection and the WHO have said that for an asymptomatic person to pass on the virus would be 'rare'. The WHO does not advocate lockdowns and Dr Nabarro of the WHO said recently 'We in the World Health Organisation do not advocate lockdowns as a primary means of controlling this virus'. Why then is the Government going against this advice and continuing with yet another lockdown?

The most important factor in this is the loss of life that will occur due to these measures. The government's own report estimates that some two hundred thousand (200,000) people will die as a direct result of lockdown — not the virus. Hospitals being closed, people not getting treatment, suicide and poverty will result in more deaths than the virus. We are told that they are being brought in to 'save lives' yet they work to the contrary. This year has seen a dramatic rise in suicides and domestic violence murders, drug and alcohol relapses and deaths due to missed treatments, especially in the elderly. The immediate deaths are not the only issue. Children and people living in abusive situations will suffer trauma which leads to worse outcomes in life, with the potential of mental health and addiction issues, ultimately shortening lives and leading to a lower quality of life.

Reports now estimate that as many as six and a half million (6,500,000) people in the UK will lose their jobs as a result of lockdown. The severe rise in poverty is also concerning as we all know poverty kills and again leads to a lower quality of life.

Isolation also kills and we are seeing the elderly deteriorate at an alarming rate due to lack of contact with families, as are prisoners who are on 23hr a day lockdowns. All of these issues will have ramifications for years to come especially upon our most vulnerable and a Government should never choose to inflict that upon its citizens.

There are many people who are on the verge of losing everything if they close their businesses, but there is a solution.

Common Law is the law of the land, which has the basis that every person has a right to freedom, liberty and protecting their income, family and livelihood. Many business owners are learning the basics of common law and are using it to stay open in lockdown without fines or threat of closure. There are many groups of people coming together and supporting each other with how to do this. KEEP YOUR BUSINESS OPEN AND DO THE FOLLOWING . . .

Put the government on notice of "conditional acceptance" NOW. They have made you an OFFER and you may accept it under CONDITIONS. The ball is then in their court, they MUST rebut your points with clear factual evidence.

Use this template below - display it in your business window and send it to the relevant government ministers, police chiefs, local Council and your MP by registered delivery.

I will conditionally accept your request to close my business on proof of the following;

- 1) A document that shows and provides scientific evidence of the testing procedure being used in this country that 100% positively identifies Covid19 otherwise known as SARS-COV-2 not ANY other type of coronavirus in a living being beyond any reasonable doubt.
- 2) You can guarantee and prove that the test being used to justify these "guidelines" will not give a false positive result.
- 3) Evidence that this is Law, because it clearly says "guidelines".
- 4) A copy of the two way contract signed by BOTH parties where I agreed to follow these "guidelines".
- 5) The government website clearly states Covid19 is no longer considered a HCID, please provide scientific proof of it being highly contagious.
- 6) Please clearly define what you mean by a "public health threat".
- 7) Can you confirm the current medical threat to a normal healthy individual (under 75) and confirm how many critically ill healthy people without any underlying conditions (only) there are in ICU so I can make an informed decision on these "guidelines".

It must be supported by an affidavit with a fully legible title, wet signature, name and address, signed and sworn or affirmed as being true, correct, complete, certain and on full commercial liability and on penalty of perjury.

Any correspondence must only be sent by registered mail. All questions 1-12 MUST be answered clearly. If no reply in the correct manner is received within 7 days it is thereby taken as your assent and agreement.
